VSEA & State Headed To Labor Board Tomorrow

VSEA's Non-Management, Corrections and Supervisory Unit Bargaining Team members and their staff negotiators will be at the Vermont Labor Relations Board (VLRB) tomorrow for a very important hearing on the "last-best" contract offers of both the workers and the State. The hearing begins at 10 a.m. at the VLRB offices on Bailey Street in Montpelier.

Because this VLRB process is such an anomaly, here's another short primer about how it works from here:

LAST BEST OFFER

Each party's last best offer (LBO) was filed with the VLRB under seal on March 21.

The VLRB is holding a hearing on the LBOs on April 7. Within 30 days of certification, the VLRB shall select between the LBOs of the parties, considered in its entirety without amendment.

Should the Board find the LBOs of both parties unreasonable and likely to produce undesirable results, or likely to result in a long-lasting negative impact upon the parties' collective bargaining relationship, the Board may select the recommendation of the fact finder as to those disputed issues submitted to the Board in the LBOs.

The decision of the Board shall be final and binding. No membership ratification vote on the LBO selection, the contract will be imposed without mutual agreement, pending appropriation.

The Board shall determine the cost of the agreement selected and request the General Assembly to appropriate the amount determined to be necessary to implement the selected agreement.

FUNDING BY THE LEGISLATURE OF THE VLRB IMPOSED AGREEMENT

If the General Assembly chooses to appropriate sufficient funds, the agreement shall become effective at the beginning of the next fiscal year.

If the General Assembly appropriates less than the amount requested, the terms of the agreement affected by the lesser appropriation shall be renegotiated based on the amount of the funds actually appropriated, and the agreement with the negotiated changes shall become effective at the beginning of the next fiscal year.

No portions of any agreement shall become effective separately except with mutual consent of both parties.

911 Board Says DPS Wants To Privatize Vermont's Entire Emergency Response System

VSEA members and many in the law enforcement community were caught by surprise this week when the Vermont Emergency 911 Board issued a press release on April 4 that began:

"The Vermont Enhanced 9-1-1 Board has been notified by Commissioner Keith Flynn that the Department of Public Safety will not be continuing to participate in the statewide 9-1-1 call taking system. The Commissioner indicated that the two Public Safety Answering Points (PSAPs) operated by the Department will cease taking 9-1-1 calls, tentatively on July 1, 2017."

The two Public Safety Answering Points (PSAPs) the 911 Board is referring to are located in Williston and Rockingham, and they are staffed by VSEA members. Almost a year ago—against strong public opposition—the State went ahead and closed Vermont's only two other State-owned PSAPs in Rutland and Derby.

The State took issue and wasted little time firing back at the Board in its own April 4 press release that read, in part:

"A press release from the E-911 Board stating that the Department of Public Safety 'will not be continuing to participate in the statewide 911 call taking system' is false. No decision has been made surrounding the participation of the Department of Public Safety in the statewide 9-1-1 call taking system. The attempt to misled the media and public is completely outrageous and under-handed."

The State's release just served to pour gasoline on the fire, as the 911 Board shot right back in another press release later in the day that included emails that seem to confirm the Board's allegations, one from a DPS official to the Board on March 23 that reads, in part:

Hi Gary [Taylor, St. Albans Public Safety Director],

Your meeting notes accurately convey what I heard in the meeting as well. DPS would like to be out of the 911 call-taking business. I know you did ask for a formal letter and that would have to come from the Commissioner. I also know that any such endeavor would take time to plan and while not meant as a date certain, for discussion sake (only) we tossed out a date of July 1, 2017. I'm sure both DPS and E911 will need to discuss this further and we are ready to do so.

As the representative for dozens of dispatchers working in Williston and Rockingham, VSEA was quick to jump into the fray to defend this critical service, issuing its own release on April 4 that reads, in part:

"VSEA and our members working at these PSAPs intend to fight any ill-advised privatization scheme with the same vigor as we did last year; hopefully with a different result this time around," says VSEA President Dave Bellini. "The Board's announcement did not provide any detail about what DPS' plan is or what the costs are associated with it, so we don't know much yet. We'll be working with our PSAP members in the coming weeks to learn whatever details there are about this privatization effort, and what its safety and financial impact could be for Vermonters and our towns and communities. If forced to, VSEA will once again stress that these dispatchers are Vermonters serving Vermonters. They know their regions and personnel, and when it comes to issues of public safety, this is very important."

Update:

On April 5, the State and the 911 Board issued a joint statement that contained the following:

"We want the public to know we are committed to working together to resolve any lingering budgetary or policy differences. Most importantly, everyone should know that regardless of any disagreements on policy, when you dial 911 you will have a dedicated state or local official on the other end of the line ready to respond. That is what we have today and we are committed to ensuring that continues to be the case going forward."

"What's missing from this damage-control statement is a position on whether or not the Williston and Rockingham PSAPs will remain State-operated or not," says VSEA Communications Director Doug Gibson. "For that reason, President Bellini is correct about VSEA not taking any chances. The union will be moving forward, hopefully again with many in the law enforcement community, to begin strategizing about how to defeat this wrongheaded, privatization scheme."

House Gov Ops Quickly Schedules 4/7 Hearing On PSAPs' Future

Apparently, lawmakers were as caught off guard by this week's news of DPS' desire to privatize Vermont's entire 911 Emergency Service as VSEA dispatchers and, it would seem, most of Vermont's law enforcement community were.

The House Government Operations Committee is wasting no time looking into the report, scheduling a hearing on this week's PSAP events for Thursday, April 7, beginning at 2:30 p.m. The hearing will be held in Room 49 at the State House. VSEA dispatcher members who are able are being urged to attend.

WIA will update readers next week on any new developments that might come out of tomorrow's hearing.

VSEA Holding S. 14 Meeting On April 12

On Tuesday, April 12, VSEA is holding a special meeting to discuss the requirements of the S.14 legislation passed in 2013. The meeting begins at 3:10 p.m. at VSEA headquarters in Montpelier.

S. 14 reads:

"Annually, the employees of the bargaining unit shall meet and discuss whether employees who have chosen not to join the employee organization shall be allowed to vote on the ratification of any collective bargaining agreement entered into pursuant to this chapter. After discussion, employees that are members of the employee organization shall vote on whether to allow employees who have chosen not to join the employee organization to vote on the ratification of any collective bargaining agreement."

Important Reminder About Messages to the Legislature or the Public!

VSEA members are under attack, both at the bargaining table and in the Legislature, and members' voices are the most powerful force we have. Members are already speaking out, particularly to legislators, so we need to remember some basic ground rules. <u>Click here</u> to view a memo that outlines some basic points about how to make sure your speech is protected. One of the key rules is this:

When you communicate with legislators, the media, or the public, make sure you are not on work time and don't use the employer's computer!

Nothing will undermine your message more effectively than the suspicion that you are using work time or the employer's property for personal purposes. Electronic messages to lawmakers should originate from your personal email account and not from your state email account. The same goes for posting on websites or blogs. Send your messages from your personal email on break time, or pre- or post-work.

Joint Safety & Health Committee Posts "Complaint Form" To Gather Data From State Employees

For years, VSEA members and staff have served with management on a specially created Joint Safety and Health Committee, which meets periodically to discuss current safety and health issues impacting state employees, your worksites and/or the public. Committee members also strategize together about

the best course of action to address a safety or health issue or concern, and they make recommendations to the State.

The Committee asked *WIA* to share that it has recently created a new downloadable "complaint" form for VSEA members to fill out and submit to the Committee if they are dealing with a safety or health issue and want to file an official complaint. The Committee will review all submitted forms at upcoming meetings to determine if action is warranted, and, if so, what kind of action is appropriate.

Threatened While On The Job? VSEA Wants To Know.

VSEA President Dave Bellini is asking all state employees who are threatened while performing your job duties to provide an account of the threat not only to your supervisor or the State, but also to VSEA.

"VSEA wants to begin to compile its own record of threats against frontline state employees, no matter your occupation," explains Bellini. "I'm asking all employees who are threatened, especially those working in AHS, to take a few minutes to fill out an online form VSEA made to collect your report. The information will help us provide a firsthand account of the number of threats being made and where they are being made, in addition to some other things."
